We are happy to announce that Webster Elementary School was selected to participate in the U.S. Department of Agriculture's (USDA) Fresh Fruit and Vegetable Program (FFVP) during the 2023-24 school year.

The goals of this grant program are to:

- Create healthier school environments by offering healthy choices.
- Expand the variety of fruits and vegetables children experience.
- Increase children's fruit and vegetable consumption.
- Make a difference in children's diets to impact their current and future health.

A fresh fruit or vegetable snack will be offered to your student two times per week. FFVP snacks will generally be served mid-day.

Teachers will provide nutrition education activities in the classroom to increase students' knowledge of the health benefits of eating fruits and vegetables. The FFVP is an excellent way to supplement other wellness programs in the school that promote health, nutrition, and physical activity.

You can support your student's efforts to increase his or her fruit and vegetable consumption in many ways. For example:

- Take your student grocery shopping. Let your student select a new fruit or veggie to try.
- Give your student options! Let your student choose which veggie to serve at dinner.
- Keep fruits and vegetables where your student can see them, such as on the counter.
- Take your student to a local farmers' market and discover fruits and vegetables in season.
- Be a role model! Let your child see you regularly eating fruits and veggies.
